Each PIAA Application for School Membership shall be signed by the Principal and shall be accompanied by the annual dues and a resolution of approval executed by the School Board or the Board having jurisdiction over the applicant school. The resolution shall state that in all matters pertaining to interscholastic athletic activities, the school shall be governed by the Constitution, By-Laws, Policies and Procedures, and Rules and Regulations of PIAA.

Membership in PIAA shall become effective the next following July 1st after the school's application receives the approval of the PIAA Board of Directors.
